WHEREAS the Central Government in exercise of the powers conferred by sub-sections (1) and (3) of Section 3 of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967) (hereinafter referred to as "the Act") has declared Popular Front of India (PFI) and its associates or affiliates or fronts vide Notification No. S.O.4559 (E) dated 27th September, 2022 (published in the Gazette of India: Extraordinary Part II. Section 3 (ii)).

AND WHEREAS by Gazette Notification No. S.O.4758(E) dated 06th October, 2022 [published in the Gazette of India: Extraordinary Part II, Section 3 (ii)] in exercise of powers under sub-section (1) of Section 5 read with subsection (1) of Section 4 of the Act, the Central Government has constituted a Tribunal comprising Hon'ble Mr. Justice Dinesh Kumar Sharma, Judge of the High Court of Delhi, for adjudicating as to whether there is sufficient cause for declaring Popular front of India (PFI) and its associates or affiliates or fronts including Rehab India Foundation (RIF), Campus Front of India (CFI), All India Imams Council (AIIC), National Confederation of Human Rights Organization (NCHRO), National Women's Front, Junior Front, Empower India Foundation and Rehab Foundation, Kerala as "Unlawful Association" as required by sub section (1) of Section 4 of the said Act.
